10 **WHEREAS** the Director of the Department of Consumer and
11 Business Services (hereinafter, "the Director") has conducted an
12 investigation of certain business activities conducted by RDSC,
13 LLC (the "Investigation"), and the Director has determined that
14 RDSC, LLC ("RDSC") effected transactions in securities for the
15 account of others in the State of Oregon in violation of ORS
16 59.005 to 59.451, 59.991 and 59.995 (the "Oregon Securities
17 Law"); and

18 **WHEREAS** RDSC wishes to resolve and settle this matter with
19 the Director;

20 **NOW THEREFORE**, as evidenced by the authorized signature
21 subscribed on this Order, RDSC hereby **CONSENTS** to entry of this
22 Order to Cease and Desist and Order Assessing Civil Penalties
23 upon the Director's Findings of Fact and Conclusions of Law as
24 stated hereinafter.

The Director **FINDS** that:

1. RDSC is a broker-dealer firm with a principal place of business at 300 Main Street; Cincinnati, OH 45202. The CRD number for RDSC is #7519.

2. Louis DeTemple is the President and Chief Compliance Officer for RDSC. The CRD number for Louis DeTemple is #1200593.

3. On or about December 5, 2008, RDSC applied to the Oregon Division of Finance and Corporate Securities ("DFCS") for a broker-dealer license (the "Application"). The Application is still pending.

4. At all times material to this Order, RDSC was not licensed in Oregon as a broker-dealer.

5. As part of the Application process, on January 9, 2009 RDSC submitted a "Pre Licensing Affidavit" to DFCS pursuant to ORS 59.245(2) (the "Affidavit"). RDSC disclosed in the Affidavit that on June 23, 2008, it effected six (6) trades for the account of one (1) Oregon resident.

6. RDSC has cooperated with the Investigation and asserts that it has modified its compliance procedures to check and confirm all address changes and to ensure proper licensing in the future.

CONCLUSIONS OF LAW
