# Do you provide housing for seasonal farm workers?

If your agricultural business employs seasonal workers for whom you plan to provide housing, you should know the following:

- **Agricultural labor housing must be registered with OR-OSHA** before it is occupied and must be re-registered each year.
- **Operators of agricultural labor housing may be fined up to \$7,000 by OR-OSHA if they fail to register** the housing before it is occupied.
- **Agricultural labor housing that has not been registered before, or whose registration has lapsed must have a pre-occupancy consultation** by OR-OSHA before it may be registered and occupied. Call OR-OSHA 45 days prior to occupancy to arrange for a consultation.
- **There is no cost for registering housing** and no cost for pre-occupancy consultation. During the consultation, OR-OSHA may require changes. The owner of the housing is responsible for making the changes and forwarding the report to OR-OSHA with the application for registration.
- **Certificates of registration must be displayed** where housing occupants will see them and OR-OSHA may review them.
