Data exclude deaths of workers not subject to Oregon Workers' Compensation coverage, such as workers who were self-employed, worked in Oregon for out-of-state employers, city of Portland police and fire employees, or federal employees. Industries are classified according to the North American Industry Classification System (NAICS), 2002 edition.
