Compensable fatalities are claims accepted by insurers arising from a fatal occupational injury or disease that entitle workers or their survivors to compensation.

Data exclude deaths of exempt workers, such as workers who were self-employed, worked in Oregon for out-of-state employers, city of Portland police and fire employees, or federal employees.
