Accepted disabling claims are claims, accepted by insurers, arising from occupational injuries or diseases that entitle workers to compensation for disability or death.

The current table includes accepted disabling claims in which either the primary or secondary source of the injury was either a forklift (source codes 8510-8519) or another powered industrial carrier (source codes 8520-8529).

Source of injury is classified according to the Occupational Injury and Illness Classification System (OIICS).

Industry is classified according to the North American Industry Classification System (NAICS), 2002 edition.

Employees of client leasing firms are reported by the industry in which they were working at the time of injury.

- Dashes indicate no claims were received.

0.0 percent indicates the percentage of claims calculates to less than 0.5 percent.
