Compensable fatalities are claims, accepted by insurers, arising from a fatal occupational injury or disease that entitles workers and/or their survivors to compensation. Data exclude deaths of workers not subject to Oregon Workers' Compensation coverage, such as workers who were self-employed, worked in Oregon for out-of-state employers, city of Portland police and fire employees, or federal employees. Injury events are classified according to the Bureau of Labor Statistics' <u>Occupational Injury and Illness Classification System</u> (OIICS).

"Other" accident events include bodily reaction, contact with electric current, railway accidents, water vehicle accidents, and drownings.

Industries are classified according to the <u>Standard Industrial Classification Manual</u> (SIC), 1987 Edition. Employees of client leasing firms are reported by the industry in which they were working at the time of injury.

During 2004, the Oregon Workers' Compensation Division began converting claims data from the Standard Industrial Classification (SIC) system to the new North American Industry Classification System (NAICS). This conversion will allow the United States to make data comparisons with Canada and Mexico. This year, tables are available for fatalities by SIC and NAICS codes.
