Compensable fatalities are claims, accepted by insurers, arising from a fatal occupational injury or disease that entitles workers and/or their survivors to compensation. Data exclude deaths of workers not subject to Oregon Workers' Compensation coverage, such as workers who were self-employed, worked in Oregon for out-of-state employers, city of Portland police and fire employees, or federal employees. Industries are classified according to the [Standard Industrial Classification Manual](#) (SIC), 1987 Edition.
