Compensable fatalities are claims accepted by insurers arising from a fatal occupational injury or disease that entitle workers and their survivors to compensation.

Data exclude deaths of exempt workers, such as workers who were self-employed, worked in Oregon for out-of-state employers, city of Portland police and fire employees, or federal employees. Claim characteristics are classified according to the Occupational Injury and Illness Classification System (OIICS Version 2.01).

Yearly fatality counts are based upon the date the Department of Consumer and Business Services received notification the fatal claim was accepted. The claim acceptance date may be different than the date of injury or illness or the date of death. Dashes indicate no claims were received.
